### We Want The Queen of Canada Welcoming You at the Border

When we are driving back to Canada the USA, we found Canadians never actually have to leave their cars and go into the Customs and Immigration Offices at the various Ports of Entry. If we did, however, we would find that most of the Canadian Ports of Entry located in Saskachewan do not have a picture of Queen Elizabeth II on display. I contacted one of the Supervisors to ask him why a picture of our Head of State was not on prominent display. He found it somewhat perplexing that I would want a picture of the "Queen of England" at all these offices. I assured him that what we were anxious to have was a portrait of Queen Elizabeth II, Queen of CANADA on display. In typical bureaucratic fashion he offered to refer me to his supervisor, thence to his, and so on. I believe there were seven supervisory levels. being particularly anxious to be referred seven times, I obtained the phone number and email address of the Hon. Stockwell Day, Minister in Charge. I sent him an email with an offer from the Monarchist League to assist in rectifying this situation. To date he has not replied. We will keep you posted on what transpires.

# HONOURS OF THE CROWN

Conclusion of the Talk given by Dr. Michael Jackson
To the Monarchist League
On October 13, 2006
Some Suggestions for Change

Our Canadian honours system, both national and provincial, is, in my view, a very good one. It has been a model for other jurisdictions. But there can always be adjustments or improvements. Here are some suggestions.

First, we need to coordinate federal and provincial honours, agree on standards, exchange information, and facilitate the work of all jurisdictions to minimize duplication and overlapping. So far Ottawa has abdicated responsibility. I hope that will change.

Next, as I'm sure all monarchists would agree, we should reverse the long-standing practice of minimizing the Queen's role in the Canadian honours system. Her Majesty is the fount of honours and Sovereign of the four national orders-but you wouldn't know it from the attitude and publicity of Rideau Hall.

Let me add that Rideau Hall has opposed conferring consistently Canadian honours on members of the Royal Family, whereas Australia and New Zealand have not hesitated to do so. Yes, the Queen Mother was made an honorary Companion of the Order of Canada in the year of her 100th birthday, but she should have received it long before-and it should not have been honorary membership, which is meant The only other for non-Canadians. Canadian honour given to Royal Family members has been the Canadian Forces Decoration to those who are colonels-inchief of Canadian regiments-but even people like me receive the CD for 12 years of service in the Canadian Forces

Only one Canadian jurisdiction has properly honoured members of our Which one? Family. Royal Saskatchewan, of course! The Prince of Wales was invested as the first honorary member of the Saskatchewan Order of Merit in 2001 and the Earl of Wessex as The Duke of the second in 2006. Edinburgh and the Earl and Countess of Wessex have received the Saskatchewan Centennial Medal and the Prince of Wales, Duchess of Cornwall, Princess Royal and Duke of York are going to.

Furthermore, during the Queen's centennial visit in 2005, her Private Secretary, Sir Robin Janvrin, and several other members of the Royal Household and staff received the Saskatchewan Centennial Medal at a special ceremony in Regina. These loyal servants of our Queen have not been properly recognized in Canada. We decided to do something about it.

Christopher McCreery has other ideas for improving the Canadian honours system. Like me, he wants to see the Royal Victorian Order awarded, as it used to be, for all forms of service to the sovereign. He also notes that Canada is one of the rare countries that does not have an order for the public service. Finally he points out the deterioration in the quality of both publications and medals of the national honours system.

Honours are one of the most significant instruments of the Crown. They recognize our best. And they should demonstrate our pride in our constitutional monarchy and in Her Majesty The Queen, who is the source of all our Canadian honours.

# Prince Charles' Poundbury

Prince Charles long has been vocal in his criticism of many developments in architecture and urban While Charles' flamboyant planning. statements employ a lot of ink, they are only a small part of his architectural Indeed, this untrained philosophy. amateur has developed a coherent and modernist critique detailed of architecture and urban planning that includes an alternative approach to replace it: his famous Ten Principles. Nor has the Prince of Wales been content to issue manifestos; he has put his considerable fortune where his mouth is, founding an architectural institute (The Prince's Foundation for the Built Environment) and creating a land development meant to epitomize his development That Poundbury, in the small Dorset county town of Dorchester.

"What I was trying to do," the prince said, "was remind people about the pointlessness of throwing away all the knowledge and experience and wisdom-wisdom-of what had gone before."

At its heart, Prince Charles' approach is environmentalist, not traditionalist. With his Principles, Prince Charles' approach is looking for a way to create a built environment that duplicates the advantages of a mature and stable ecology, a livable environment that is harmonious and egalitarian.

Unlike the conventional developments the prince so despises, Poundbury follows a design of almost unnerving boldness despite its cozy oldworld atmosphere. Dotted with offices and several inconspicuous factories, it is densely packed, enabling many residents

to walk to work, and its tight lanes and snaking avenues are meant to baffle motorists. "If you design with the pedestrian at the centre, not the car," the prince said, "then you tend automatically to produce a more livable community."

Poundbury starts as a village, a packed centre of mixed tightly architecture and uses. Its well-defined centre, removed from the noisy main road, has a market square with a guildhall raised on bulbous columns above an open piazza, a small grocery store, a very nice pub and several shops. Both the pub and a tea shop provide outdoor seating on sunny days, and the square is invariably mobbed. Narrow streets radiate chaotically. The planners actually laid out the building lots, then fitted the streets in between them, so the lanes tend to make random jerks. Like the great 18th-century projects, the developers that act for Prince Charles have established rules that impose a common architectural language while allowing individuals a great deal of designing their freedom in buildings.

Indeed, Poundbury is so successful that it has spawned smaller versions of itself elsewhere in the duchy, and a bigger version is set to rise next to the Cornish town of Newquay. planning ideas in Poundbury are a challenge the blandly serious to impersonal modernist developments that all too perfectly capture the spirit of a machine-dominated age. The prince's hope that his vision will shape urban living beyond the duchy seems to be coming true. Curious city planners and high officials from numerous countries have come to see Poundbury.

#### A REVIEW OF THE FILM "THE QUEEN".

The success of this film at the recent Holywood Oscars event was a really excellent tribute to a film which focused on the events surrounding the death of the late Diana, Princess of Wales. Dame Helen Mirren's portrayal of Her Majesty the Queen was outstanding. There were some scenes when one wondered if HM herself was part of the cast, so well was she portrayed. Opinions of the film will vary according to how you judge what took place 10 years ago this coming August. Prince Philip was well played as was The Prince of Wales. The portrayal of the late Queen Mother left some questions. Prime Minister Tony Blair was very well portrayed and his steadfast influence at that time came across extremely well. Diana's sudden death was one of the new P.M.'s biggest challenges and he was able to assist The Queen in her ultimate decision-making after a traumatic event which deeply affected the Royal Family, leading to its reappraisal of its role in the lives of Her Majesty's subjects. This is a film which requires to be seen and not evaluated by the thoughts of its critics. How touching it was to see Dame Helen Mirren publicly recognize the honour she felt in playing the part of The Queen as she accepted her Oscar for Best Female Actress.
